

WORK REHABILITATION PRACTITIONER CERTIFICATE PROGRAM FAQ

The Work Rehabilitation Practitioner Certificate Program is set up as a self-paced, on-demand Learning Plan in the WorkWell Provider Learning Center at www.workwellprovidertraining.com. It is comprised of 8 training Modules plus a final Case Study Assignment Submission. The Case Study will be the final project required for the Work Rehabilitation Practitioner Certificate. A passing score of 80% on each of the 8 Modules plus the graded Case Study will lead to the successful completion of the Learning Plan. The program is designed to be completed over the course of several weeks, and the Case Study can be based on a patient/client seen by the practitioner during that time.

Upon successful completion of the Program, you will be eligible to receive your Work Rehabilitation Practitioner Certificate from WorkWell. Your certification will be valid for 5 years, after which you may renew it by completing all updated course content.

I have already taken some of these Modules online or on demand. How do I qualify for the Work Rehabilitation Practitioner Certificate?

- The Work Rehabilitation content has been enhanced and updated since being offered online/live.
- You must complete all of the on-demand Modules and the Case Study assignment to receive the Work Rehabilitation Practitioner Certificate.
- Upon purchase, any on-demand Modules completed since 1/1/2023 will be counted as "complete" in the Learning Plan. The Module will remain available for review, but you will not need to complete it again.

How long do I have to complete the Work Rehabilitation Practitioner Certificate Program after I purchase it?

- Access to the Program will be valid for 365 days from the date of purchase

What happens if I don't complete the Modules or Case Study submission within 365 days of purchase?

- Content will expire and no longer be available if not completed within 365 days of purchase.
- Re-enrollment after 365 days will require repurchase of the Program

What if I took some of these on-demand Modules when I was working at a facility with a WorkWell Easy Train Membership and am no longer working there but wish to pursue completion of the Work Rehabilitation Practitioner Certificate Program?
